# TEEN DATING VIOLENCE AWARENESS MONTH

Options representatives Rachel Chambers and Jennifer Hecker presented a Teen Dating Violence

Awareness Month 2018 Proclamation for February. Chair Haselhorst read the Proclamation.

# **Teen Dating Violence Awareness Month 2018**

WHEREAS intimate partner relationships are often counted among life's greatest blessings, and tragically, many relationships are tarnished by violence and fear. Although the dynamics of teen dating violence are similar to adult domestic violence, the forms and experience of teen dating violence, as well as the challenges in seeking services, make the problem of teen dating violence unique; and

WHEREAS females between the ages 16-24 are more vulnerable to intimate partner violence, experiencing abuse at a rate almost triple the national average; and

WHEREAS one in three adolescent girls in the United States is a victim of physical, emotional or verbal abuse from a dating partner, a figure that far exceeds victimization rates for other types of violence affecting youth; and

WHEREAS violent relationships in adolescence can have serious ramifications by putting the victims at higher risk for substance abuse, eating disorders, risky sexual behavior and further dating violence; and

WHEREAS only 33% of teens who are in an abusive relationship ever tell anyone about the abuse, and 81% of parents surveyed believe teen dating violence is not an issue; and

WHEREAS by providing young people with education about healthy relationships and by changing attitudes that support violence, we recognize that dating violence can be prevented; and

WHEREAS everyone has the right to a safe and healthy relationship and to be free from abuse;

NOW, THEREFORE, the Board of County Commissioners does hereby proclaim February 2018, as **Teen Dating Violence Awareness Month** in ELLIS COUNTY, Kansas, and encourage all citizens to speak out against teen dating violence, to provide support for survivors of these crimes, to encourage community leaders to hold perpetrators accountable, and to make teen dating violence prevention efforts a priority by hosting events, by creating policies at schools and to provide training for teachers, counselors, school staff and parents so that they may recognize when youth are exhibiting signs of dating violence and by working with our local victim service providers.

### **EXTENSION REPORT**

Cottonwood Extension District 4-H and Youth Agent Susan Schlichting reported on current activities. Forty-six individuals attended fair judges training which was held in Hays. Agent Schlichting was pleased to announce that 4-Her Jacob Schmeidler had his Space Tech and Ag Advocacy Project advance onto State competition. Four Ellis County 4-Hers took honors at the Kansas Horse Panorama in the public speaking competition. The first 4-H market beef weigh-in had 53 animals. Agent Schlichting

is very pleased with the SPIN 4-H Club that continues with teen leadership development. 4-H Club Day is on March 4<sup>th</sup> at Ellis. Ellis County had two 4-Hers involved in a trainer workshop in Ames, Iowa. They will be sharing their skills with the Monarchs on the Move Project in teaching 50 youth. Activities will include planting seeds to attract more butterflies and in identifying the insects. Real World 101 through the Leadership Class at Fort Hays State University will be providing opportunities in preparing college students with life skills after college. The last session they had 115 students participating in this class. Agent Schlichting shared that the upcoming 4-H Fiber Fun Days is for 4-Hers to see wool spinning, color dying and techniques in working with wool.

### **FIVE-YEAR FINANCIAL FORECAST**

County Administrator Smith-Hanes reviewed a five-year financial forecast. He presented a power point presentation showing a County spreadsheet and showed different scenarios in regarding the financial budget for the next five years.

He shared budget projections in planning for the future budget years. He said it is hard to project with factors such as the property tax rate, property and oil values, and cost of employee salaries and benefits. Health insurance has shown an increase.

Through his projections, the 2020 Budget could be the challenge. Factors that could influence budget increases, would be by increasing property taxes and reducing spending.

It was noted that the Register of Deeds will collect less revenues as this year ends the mortgage registration tax.

Commissioners clearly wish to get a handle on upcoming budgets.

County Administrator Smith-Hanes stated that he needs direction from the Commission to share in preparing for the upcoming 2019 Budget.
